

that FRANK DIOGUARDI (MM 92-405), JOE INDELICATO (MM 92-404) and JOE MILSTEIN (MM 92-1360) have been seen hanging around there.

MM 509-C-TE advised a new gambling club called the Collins Hungarian Civic Group Club, opened at 618 Collins Ave., Miami Beach. The principal card games are poker, Greek rummy and blackjack. The operators are HARRY PAPIER, alleged to be a fence and part owner of the Biscayne Valet Laundry, Miami Beach; RUTH GASSENHEIMER, owner of the Patio Bridge Club, Miami Beach, and BEN HUSICK (MM 165-332). Reportedly HUSICK was taken in as one of the operators of the club as he was able to secure the "OK" and is able to handle the "fix" with the local law enforcement agencies. AL STERN, a gambler and dealer who recently arrived from Las Vegas, is the manager and the dealers are HERSHIE (LNU); STANLEY WILLIAMS and STANLEY STANN, to date.

He also advised ABE SCHLETSKY, a gambler, left for Las Vegas, Nevada. SCHETSKY just invested some money and became a partner of ALFIE MART (MM 162-14) in the Derby Horse Room and LOUIS BLACKER, a gambler and Miami Beach laundry operators, acquired a piece of SCHLETSKY's financial interest.

MM 962-PC reported that SOL EDER (MM 165-208) accompanied by his brother, CORNELIUS EDER, a resident of New York City, visited at the office of the National Plastering Co., Miami Beach, operated by MAX EDER (MM 92-467) and JACK RUBIN.
