Enclosed herewith is the original and 5 copies of an LHM containing information regarding JACK RUBIN.

CONF. INFT. On December 12, 1967, former MM 962-C on instructions from hoodlum MAX EDER went to JACK RUBIN's Miami Beach residence where together with RUBIN's mother they found RUBIN in an unconscious state in his bedroom. Informant found a suicide note in the bedroom which informant took, without showing it to RUBIN's mother, directly to MAX EDER. EDER told informant not to show the note to anyone, even the police, which orders informant kept. EDER told informant that if anyone questioned her regarding RUBIN's condition. informant was to tell them that RUBIN had gone into a Informant furnished the contents of diabetic shock. the letter to the FBI in strictest confidence stating that if the information was divulged to anyone, EDER would know that it came from the informant.

Since above information has not been verified or substantiated and since the informant was the only person with the exception of EDER to have access to this information, and it was furnished to the FBI in strictest confidence; it is not being included in enclosed LHM, UCAB.
