Re: JACK RUBIN

On April 10, 1964, a confidential source advised the FBI that JACK RUBIN and MAX EDER were co-owners of the National Plastering Company, 1911 W. Avenue, Miami Beach, Florida for the past one and a half years. Investigation in the past has disclosed that MAX EDER is a hoodlum and racketeer in the Miami, Florida area. He has been based in the Fontainebleau Hotel, largest and best known hotel in the Miami area to protect the hoodlum and racketeer interest therein. Business dealings at the National Plastering Company have also brought RUBIN into contact with other hoodlum friends of EDER.

On April 21, 1964, a confidential source advised the FBI that JACK RUBIN owns one share in the National Plastering Company and draws a weekly salary of \$250. plus quarterly bonuses. RUBIN is considered an excellent plastering man who knows the plastering business very well and actually handles all of the National Plastering Company's operations pertaining to plastering work.

According to the Florida Corporation Charter dated July 27, 1961, the following officers for the National Plastering Company were listed:

President - TERRY RUBIN
(wife of JACK RUBIN, listed for corporate purposes only);

Secretary-Treasurer - JACK RUBIN;

Vice President - MAX EDER

As of June 6, 1958, JACK RUBIN was under a U.S. Government tax lien in the amount of \$30,195. This lien was entered against the Rubin Brothers Plastering Company of which firm JACK RUBIN was a co-owner at the time, by the Director of the Internal Revenue Service (IRS).
