On 2/10/65, [redacted] aka [redacted] PSI-Cuba, who has furnished reliable information in the past gave SA JOHN D. HURLEY, JR. a 16 page memorandum in the Spanish language which he had received on 2/6/65 at the Casa de las Americas. [redacted] advised that copies of this memorandum were distributed to those in attendance at the CDLA on this occasion. (S) (u)

OTHER 1B, 4

[redacted] further advised that OTTO MARRERO, Attache Cuban Mission to the UN, who was present at the CDLA on this occasion, was overheard talking to some CDLA members about MENOYO. [redacted] states that MARRERO said the Cuban government did not execute MENOYO because they probably will exchange him for some Communists who are in prisons in other countries. [redacted] said MARRERO appeared to be guessing and not speaking officially.

Enclosed for the Bureau are the original 16 page memorandum in the Spanish language and two English translations of same prepared by the NYO Translation Unit. One English language information copy is being sent to the Miami Office as an enclosure.
