On page five MM T-2 is described as American citizen of Cuban origin who is acquainted with the subject and who is a former member and official of the July 26 Club of Miami. T-2 is described in the administrative pages as Legat, Madrid, letter to Bureau 9-27-60. This is not a satisfactory identification of T-2. (W)

Review of subject's file indicates that Madrid letter 9-27-60 under the subject's caption makes no mention of such an individual. It is possible, however, the information in rerep was based on some other letter from Legat, Madrid. Clarify and advise Bureau and interested offices as to the identity of T-2 and the exact date and caption of the letter which contained this information. Charge error of form to appropriate personnel. (W)
