Re Madrid letter 11-29-60.

On 12-5-60 information that subject might possibly return to Spain under an assumed name and that this name might possibly be KIKO PERNAS was furnished to Mr. JOSE CEPEDA BRAVO of the Directorate General of Security in Madrid. Mr. CEPEDA is one of the agents working investigations of Cuban matters by the Directorate General of Security and he was most appreciative of this information. (S)

Mr. CEPEDA said that it would be of considerable value to him to have a photograph of the subject. It is requested that if a photograph is available in Bufiles, two copies of same be furnished to the Madrid Office. If Bufiles contain no photograph it is requested that the Bureau give consideration to having the appropriate office check I&NS files to determine whether or not a photograph is available in the files (S)
