By letter dated 1/11/61, the Legal Attache, Paris, forwarded to the Bureau a letterhead memorandum concerning the subject and GONZALEZ ARTURO MATA-LLEDO. Paris also forwarded a summary memorandum in French of the organization known as "Directorio Revolucionario Iberico de Liberacion" (D. R. I. L.), requesting that it be translated. (C)

The summary memorandum has, in part, been translated. A copy of the completed portion of the translation is enclosed herewith for the information of San Antonio which is presently in the process of interviewing MENOYO. The remainder of the translation will be furnished to San Antonio upon completion. (u)

Also enclosed for San Antonio is a copy of the letter from the Legal Attache, Paris, dated 1/11/61 and a copy of the letterhead memorandum mentioned above. (u)
