[redacted] advised that all information he furnished concerning MENOYO originated with ZENAIDA MARRERO, telephone FR 34369, address 1332 NW 2nd St., Miami, Fla., wife of RENE DECHARD, formerly with Cuban State Department in Havana and before that Cuban Consul in Tampa, who has broken with CASTRO government. She is his wife's sister and he claims she has been violently anti-Communist all her life, has known MENOYO well for many years, will vouch for him, and can furnish information concerning incidents which will substantiate a history of anti-Communism. (X)(U)

OTHER 4

[redacted] who is under development as a PSI and is considered reliable, advised that he himself met MENOYO once when MENOYO came to Tampa at his invitation the last of December, 1959, to attend a fund raising meeting. On that occasion MENOYO told him in confidence that he was convinced that CASTRO was a Communist. MENOYO said, however, that the time was not ripe to start action against CASTRO, as he at that time still had the confidence of the people, and suggested that it would probably be the summer of 1960 before any effective action could be initiated against CASTRO. 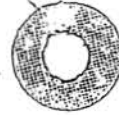
