Following the forwarding of relet, a memorandum was received from the Belgian Security Service which enclosed the attached clipping from the Belgian newspaper La Derniere Heure of 2/12/61. The Belgian Security Service pointed out that this article indicates that the captioned subject is reported to be intermed by American Immigration authorities in the State of Texas. They requested that they be furnished with any pertinent information in our possession regarding the subject or with pertinent information obtained in the event he is interviewed by the Bureau. (5)
