CUBAN REVOLUTIONARY MATTERS

On September 11, 1959, information was furnished by a source whose reliability is doubtful and who claims to have received information from a Dominican official in the United States on September 2, 1959, that there are Russian intelligence agents in Cuba; that FIDEL CASTRO has bought weapons from Czechoslovakia and that one of BATISTA's former generals, (FNU) LOPEZ, paid one Captain MORGAN approximately \$80,000.00 in cash some months ago for aiding the Dominican Republic; that it was the same MORGAN who was highly publicized in the newspapers for delivering men and materials to CASTRO's men in Cuba under such conditions that the men were captured as Dominican Republic agents. This same source advised that the Dominican official also expressed the opinion that Dominican Republic officials believed MORGAN was still working for that country not withstanding his actions.

This memorandum is loaned to you by the FBI, and neither it nor its contents are to be distributed outside the agency to which loaned.
