Reurlet and memorandum 9/7/61, entitled "Otto Karol Kocourek," your file 105-4464, and Legat, Ottawa's, letters, both dated 8/28/61, entitled "Karol Otto Kocourek)" (S)

Since RCMP is interviewing Kocourek at present time and has furnished his name as Karol Otto Kocourek, it appears that is his correct name. Review of Bufiles concerning subject shows that one Yolanda de la Torre de Savoy, according to Department of Army, reportedly was living with William Morgan in Havana as of January, 1960. She was described as wife of one Savoy, an American citizen employed at Cape Canaveral, Florida. Investigation in the case entitled "Savoy," your file 105-2293, failed to identify Mr. Savoy and you determined that no individual named Savoy was employed at Cape Canaveral as of January, 1960.

Identifying data concerning subject is meager although, it is noted she is described as a divorcee and it is possible that she is identical with the individual who reportedly was living with Morgan. It is also noted that data furnished by her concerning Kocourek appears to be self-serving as concerns Kocourek and the personal relationship between the two makes data furnished by her somewhat suspect as, to our knowledge, Kocourek is not giving RCMP data concerning his activities which would indicate he was deeply involved in assisting anti-Castro underground in Cuba as subject has indicated.

Conduct sufficient background concerning subject to determine if she is the individual who was living with Morgan and, if so, interview her fully as to a former husband who possibly was employed at Cape Canaveral. If it is determined that such an individual exists, Tampa should be advised and Tampa should give consideration to Security of Government Employees investigation of him.
