NY T-1 is MIGUEL ANTONIO SANCHEZ RAMOS, subject of Bufile 97-4351, who was interviewed on 12/17/60, by SAS EDWARD J. DEVINS and HEINRICH VON ECKARDT in Room 615, Roger Williams Hotel, 28 East 31st Street, NYC. His identity must be concealed.

It should be noted that SANCHEZ is acquainted with a Priest named Father (first name unknown) VELAZCO. It is thought that this individual is most likely identical with RICARDO VELASCO ORDONEZ; however, the Bureau may desire to withhold dissemination of the attached memorandum pending the reinterview of the subject by the San Juan Office.

SANCHEZ was personally present in the Office of ABBES on 8/14 or 15/59, just prior to the departure of the C-46 for Cuba. He personally heard ABBES tell a runner "Go to the El Paz Hotel and wake up the Priest. I bet he's drunk". SANCHEZ did not see Father VELAZCO on this occasion, and did not personally see Father VELAZCO until approximately February or March, 1960, when he saw Father VELAZCO in the office of CANDIDO TORRES. SANCHEZ was personally present in TORRES' office when VELAZCO furnished information implicating the Roman Catholic Church with the January, 1960 plot. He sat next to Father VELAZCO in the Cathedral at the time of the stink bomb incident. Father VELAZCO did not recognize him. When Father VELAZCO mentioned "sacrilegeous, profane, etc.", SANCHEZ told him "Shut up Father, this is an SIM deal", at which time Father VELAZCO made no further mention of the stink bombs. SANCHEZ personally observed Father VELAZCO receiving a yellow envelope from Lieutenant COLON.

It is noted that during the continuous interview of SANCHEZ, he has made reference to the SIM campaign against the Roman Catholic Church in the Dominican Republic. During the continuing interview, full details concerning this matter will be obtained from SANCHEZ and the results will be made the subject matter of a separate communication.
