Reference is made to the memorandum dated October 25, 1961, at Baltimore, Maryland, captioned "Wayne Rider Powell, IS - Cuba; Jerry Michael Welsh, IS - Cuba."

Enclosed for each recipient is a copy of a memorandum dated December 11, 1961, at Baltimore, Maryland, entitled "Wayne Rider Powell, Jerry Michael Welsh." Also enclosed for each recipient are single copies of the envelope and letter mentioned in the memorandum.

It is requested that recipient agencies advise as to whether they have or can obtain any information regarding "Apartado 3026, Habana, Cuba." We would be particularly interested in background data on the individual to whom this post office box might be registered. If it is registered to the Cuban Government, we would appreciate being advised as to whether recipient agencies have received any prior data indicating that the post office box is being utilized by the Cuban Government for the receipt of information from pro-Castro individuals in the United States. We would appreciate an early reply in this matter.
