On November 7, 1960, PSI ELIO QUINTERO, Miami, Florida, who allegedly has had contact with Cuban intelligence activities in Miami area, advised that no information has come to his attention to indicate that information concerning anti-CASTRO activities from Miami is furnished to contacts in areas other than Cuba.

On November 7, 1960, PSI [redacted] a recently defected G-2 Agent in the United States, advised that no intelligence information is sent directly from Miami to points other than Cuba. In turn, it is then disseminated to "agencies" of Cuban Government located in countries other than Cuba.

Inasmuch as this information is of a negative nature, it is not set forth in form suitable for dissemination.

No further action is being taken by the Miami Office.
