Bonn should furnish Bern with background data concerning the subject. Paris obtain the subject's current address from CS PAR-19 and furnish this information to Bern. (U) (S)

Upon receipt of the above, Bern should arrange through appropriate Swiss authorities to interview the subject. In the event Bern feels Swiss authorities should not be contacted in this regard Bern should submit its recommendation to the Bureau as to the handling of this interview. (U) (S)

NOTE:

Subject, presently residing Geneva, Switzerland, was formerly a highly-placed official in the Cuban Economic Ministry. Subject escaped from Cuba late in 1962. [PAR-19] (U) has kept us advised of subject's whereabouts and this informant feels the subject would consent to interview by Bureau representative. Liaison Agent S. J. Papich contacted Mrs. Jane Roman, CIA, 10/22/63 re subject. (U) (S)
