In order to identify the leaders and to determine the activities of this organization in Mexico D.F., Mexico; Rio De Janiero, Brazil; Buenos Aires, Argentina; Caracas, Venezuela; and in the Dominican Republic (DR), the Bureau is requested to set out the following leads: (S)

1. Request investigation in Mexico D.F., Mexico to identify the leaders and determine the activities in that area of captioned organization (S)(U)
2. Request Legat in Rio De Janiero, Brazil, to identify the leaders and determine activities in Rio De Janiero and in Buenos Aires (S)
3. Request appropriate liaison representatives in Caracas, Venezuela and Ciudad Trujillo, DR, to identify leaders and determine the activities in those cities. (S)(U)
