1. This is with reference to our communication CSCI-3/766,521 dated 27 July 1961 and your reply dated 2 August 1961 concerning Subject.
2. The Bureau information incorporated in the summary data on Subject was:

"During his New York City tenure, he was known to write bank drafts to persons known to be active Communist workers. It was suggested that he was used as a means of financing Communist Party activities." (S) (u)

The above conclusion was apparently based on numerous Bureau reports written during 1957 and 1958 when Subject was assigned to the United Nations in New York City. (S)

3. It is noted that your file number of this case was [105-24642] (S) and your New York office file number was [105-21857]. It appears that the agent's name was David R. Evans, Jr. (S)

4. One of the persons Subject had written a bank draft to was Alicia Merino Fuentes (your file number [100-15516]) and your report dated 12 October 1956 contained information that she was an active Communist worker. (S)

5. Expeditious action by you concerning permission to pass the information quoted in paragraph 2 above to the German authorities will be appreciated. (S)
