The title of this case is being marked changed to show subject's complete name as reported by Mr. JACK EVERHART, former acquaintance of source GIQUEL Title was previously carried as (FNU) AMUCHASTAGUI.

Re Washington Field letter to Bureau, 9/6/61, and Buairtel dated 9/27/61.

The following investigation was conducted by SA ROBERT G. STRONG:

Dr. JOSE LASTRA CAMPS, 2365 Pinetree Drive, Apt. #2, Miami Beach, Fla., advised 9/29/61 that he is the brother of SERAFINA LASTRA CAMPS DE GIQUEL. SERAFINA visited with him for one month in 6/61. She is the wife of SERGIO GIQUEL, a Dentist in Havana, who has not been able to obtain permission to leave Cuba.

She is to remain indefinitely in Cuba. Dr. LASTRA is the only relative in the United States. He recalled that she conversed with a representative of the U. S. Govt. re some matter re a person in Cuba but he did not know the details of the conversation. Dr. LASTRA stated that Mr. JACK EVERHART, an acquaintance of source, may have info re the matter in reairtel.

On 10/2/61, Mr. JACK EVERHART, 13140 SW 82nd Ave., Miami, advised that he is a close acquaintance of the CIA source (SERAFINA GIQUEL). He said that she reported to him the info she had furnished to CIA in 6/61. He stated that the individual's name was not AMUCHASTAGUI but MARIO GARCIA INCHAUSTEGUI, the Cuban representative to the United Nations. He did not remember the exact info concerning INCHAUSTEGUI, other than the fact that he was to arrive in the U. S. and cause trouble. Details of how he was to cause this trouble was not recalled by EVERHART. He said that the CIA source, (GIQUEL) does have many contacts in Cuba and any info she may have furnished, in his opinion, would be fairly reliable (S)(u)

Miami indices show MARIO GARCIA INCHAUSTEGUI was Cuban Ambassador to Montevideo. See Miami letter to Bureau, 2/2/61, captioned "MARIA DEL CARMEN RODRIGUEZ CASANOVA, aka. IS - CUBA". Enclosed with letter was a "List of Cuban Foreign Service Offices Abroad". INCHAUSTEGUI's name appears on pages 74 and 96. Miami indices also show MARIO GARCIA INCHAUSTIGUI as a member of the Cuban Mission to the United Nations with the rank of Ambassador. See Miami teletype to Bureau and N. Y. dated 7/29/61, captioned "Cuban Mission to United Nations, IS - CUBA". (S)(u)

Investigator MICHAEL REDMON, INS, Miami, advised 10/2/61, that INS files contain no info re INCHAUSTEGUI.

It is apparent that INCHAUSTEGUI is not identical to DOMINGO AMUCHASTEGUI ALVAREZ and Washington Field should remove stop placed with the central office of INS.
