On 9/18/61, MM-726-S advised SA Leman L. Stafford, Jr. he had ascertained that subject has two vessels which are located on the Miami River, Miami, Florida. According to informant, subject and his wife are both receiving money from the Cuban anti-Castro organization, FRENTE REVOLUCIONARIO DEMOCRATICO (FRD) and live on one of these vessels. Informant stated subject apparently monitors the marine band which is also used by Cuban radio stations and he is apparently taking some of the data received and furnishing it to the FRD headquarters.

Informant said it has been rumored that at times subject ! has made certain transmissions on 2764 kilocycles in an effort to disrupt the communications of the Cuban radio stations which operate on this frequency. Informant was unable to state if such rumor is true. Informant learned that subject reportedly is installing a broadcast transmitter for the purpose of beaming anti-Castro propaganda to Cuba, and it is reported that such transmissions will be carried out from the vessel 'Monterrey."
