Rereps of SA GEORGE E. DAVIS, JR., dated 10/3/61, at Miami, Florida, and of SA FRANCIS J. O'BRIEN dated 10/31/61, at New York.

On 10/18/61, and 11/1/61, WFO CS RAMIRO LOYS (protect and designate as having furnished reliable information in the past) advised that, according to information furnished to him by several sources, the Cuban nationals ANDRES ZAYAS and GUILLAN ROSS were in Washington, D. C., in late August, 1961, or early September, 1961. The informant said that these two Cuban nationals reputedly represented sabotage groups active in Cuba. In Washington, D. C., they were known to have been in close contact with FRANCISCO FERNANDEZ CABADA, JR. (Bufile 105-101229; WFO file 105-43197) in order to coordinate with CABADA's requests for assistance from the U. S. for activities in Cuba. The informant said that as far as he could ascertain, all of these persons have now left the Washington, D. C., area.

It is noted that by letter dated 8/8/61, the Bureau advised WFO that on 8/3/61, CIA orally advised that CABADA is a member of Unidad Revolucionaria, an anti-CASTRO organization.

It is further noted that by communication classified "Secret" dated 8/9/61, CIA informed the Bureau of its operational interest in FRANCISCO FERNANDEZ CABADA, JR. (S) (U)
