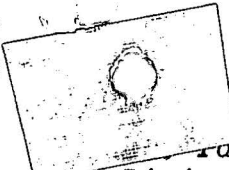

Based on data furnished, no information identifiable with captioned individual was located in the files of the Federal Bureau of Investigation.

Handwritten address: 404 3rd AVE, HULLWOOD, VA

The files of the Passport Office, Department of State, reviewed by a Special Agent of the FBI on September 13, 1961, disclosed that no passport bearing the number A8922937 has ever been issued and that no passport has been issued to anyone with the name of the captioned individual.

The files of the Central Office of the Immigration and Naturalization Service were reviewed by a Special Agent of the FBI on September 13, 1961, and showed that one Fernando Maciel Padilla had registered as an alien and had been assigned Alien Registration Number A8922937; however, there was no further record of this individual in the files of that office and it was indicated that his file is located in the office of the Immigration and Naturalization Service at El Paso, Texas.

Permission is granted to furnish the above information to authorities in Guatemala provided that the FBI is not named as the source.
