 TWENTY LAST SOI ALFONSO <sup>Informant</sup> MONTES, COORDINATOR, FRENTE REVOLUCIONARIO  
 DEMOCRATICO ANTI CASTRO ORGANIZATION, PROTECT, ADVISED ON THAT DATE  
 WHITE MALE JOE LNU, AGE TWENTYFIVE, CONTACTED HIM OFFERING TO SELL ARMS  
 AND AMMUNITION TO ANTI CASTRO FORCES. CLAIMED TO BE SALESMAN FOR
