1. The Deputy Director, Plans is in receipt of a copy of a State Department memorandum dated 16 October 1959 addressed to the FBI Director entitled "Alleged Soviet Activities in Republic of Cuba". [From the contents of this memorandum it appears the ultimate source of it may be Paul B. HICKMAN, mentioned in your communication of 18 September 1959, (file no. 64-211-210) to the Director of the Central Intelligence Agency, [who has recently been apprehended in Switzerland for questioning by the Swiss Federal Police] in conjunction with the FBI representative in Paris.] (S)

2. We should appreciate being advised if your investigations (S) of the HICKMAN case reveal that he is the ultimate source of the contents of the aforementioned memorandum, or if not, the name of the person who did supply the information. Should you have no plans to determine the ultimate source of the memorandum we should also appreciate being so advised.
