On February 21, 1963, Austin Horn, Central Intelligence Agency (CIA), made reference to the "Roberto" radio message dated February 18, 1963, which included the names of: (1) Lopez Fresquet, (2) Jorge Barcelo, (3) Vega Lopez, and (4) Del Rio. (S)(U)

CIA believes that three of the individuals mentioned above may be: (S)(U)

(1) Rufo Lopez Fresquet who, in May, 1962, allegedly was living in Bradenton, Florida. (S)(U)

(2) Jorge Jorge Barcelo who was utilized as an informant by CIA in Costa Rica. In February, 1963, this individual left Costa Rica for Miami and is believed to be residing at 6050 Southwest 114th Street, Miami. (S)(U)

(3) Flores Fernandez Vega Lopez, who is currently living in Costa Rica. (S)(U)

Horn stated that his Agency would appreciate receiving any pertinent information which the Bureau might possess concerning Rufo Lopez Fresquet and Jorge Jorge Barcelo. He explained that he was currently checking to determine the status of CIA's current relationship with Barcelo. (S)(U)

ACTION:

The above information and CIA request will be directed to the attention of the Nationalities Intelligence Section. The reply to CIA should be transmitted via Liaison. (S)(U)
