The following information was furnished to the Liaison Agent on 9-13-61, by Mrs. Jane Roman, Central Intelligence Agency (CIA). *(S) (u)*

The subject is a former economic advisor of the Cuban Embassy in Brussels, Belgium. Several weeks ago, he defected and established residence in West Germany. He has a German wife and is endeavoring to emigrate to the U.S. *(S) (u)*

Mrs. Roman stated that CIA gave consideration to possibly exploiting subject from an operational standpoint, but after studying possibilities, discontinued such interest. CIA came to the conclusion that subject did not have enough to offer. *(S) (u)*
