Re NY airtel to Director, 11/27/61 and Bulet
to Director, CIA, dated 12/14/61, captioned as above.

Dr. ERNESTO ARAGON, 233 East 69th Street, secretary
to Dr. JOSE MIRO CARDONA, head of the Revolutionary Council,
advised on 12/19/61, that he had received the plans and dia-
grams for the communications system, which had been installed
in Cuba from 1956 to 1959, by ROBERT W. HALL of Glenside,
Pennsylvania.

ARAGON advised that he had been in Washington, D.C. .
from 12/5 to 12/11/61, with Dr. MIRO CARDONA and while in
Washington, HALL had sent these plans to his home and ARAGON's
wife then sent them to him in Washington. ARAGON stated that
he had copies of the plans made up but gave the original plans
of the communications system to Dr. JOSE MIRO CARDONA, who
in turn was to give them personally to the CIA in Miami,
Florida.

ARAGON exhibited to the NYO, a copy of these plans
but the NYO did not make any copy as the original was already
in the hands of Dr. MIRO CARDONA and was to be turned over
to CIA in Miami, Florida.
