Liaison was requested to determine the nature and extent of Central Intelligence Agency (CIA) past or present relationship with the subject. *(S)(U)*

On October 30, 1960, Mrs. Jane Roman, CIA, advised that the subject had been utilized by CIA in Cuba as a source of information. She was discontinued as a source after she came to the U.S. several months ago. The agency has no plan for any future use of Guerra. *(S)(U)*

was CIA has no derogatory information concerning her and she *is* characterized as a routine type of source. *(S)(U)*
