Enclosed for the Bureau are 9 copies of a letterhead memorandum captioned "PEDRO PABLO PRIETO, SM - C; BERTA NOVOA, SM - C" and dated as above with an equal number of reliability memorandums. The confidential informant referred to in the enclosed letterhead memorandum is former SJ PSI ROBERT LANDS who is Business Manager of TV Station WKAQ-TV.

The Bureau is requested through [the Central Intelligence Agency] and other available sources to determine at Havana Cuba, the reputation of the captioned subjects and their affiliation, if any, with the Communist Party or other subversive organizations. An effort should also be made to determine if the subjects are representatives of any CASTRO Intelligence Agency.
