Re San Juan airtel 10-4-63, and BUairtel 10-8-63.

Sergeant William Stewart, Directory of Security and Intelligence, RCMP Headquarters, on this date advised investigation at the Hotel de Province, Montreal, Quebec, disclosed one Braulio Martinez, who listed his address as 321 R. Sur, San Juan, P. R., occupied room 217 from 9-12-63, to 9-24-63. (S)

On 9-14-63, he placed a collect call to San Juan, P. R., telephone number 722-7028. He also reportedly made calls during the above period to Cubana Airlines and the Cuban Trade Office, both in Montreal. According to the RCMP, the subject made comments to a source of the Force in the Hotel de Province indicating he was connected with a trade union movement. (S)

The RCMP's investigation is continuing and to date no information has been developed as to present whereabouts of subject. (S)
