MARTINEZ, TOOK PLACE FOLLOWING THE ABOVE INTERROGATION AND IN THE PARKING LOT OF THE MEDICAL CENTER. AS FAR AS HE KNOWS, NO ONE ELSE WAS A WITNESS TO IT. MARTINEZ SUBSEQUENTLY INTERROGATION, NOVEMBER 25, AT THE CUBAN EMBASSY, HAS BEEN CORROBORATED BY INFORMATION FURNISHED BY [WF 113-S\*] HOWEVER, DURING THE PORTION (S) OF HIS INTERROGATION AT THE EMBASSY WHICH WAS RECORDED BY DR. ARMANDO FLOREZ, CUBAN CHARGE D'AFFAIRS AD INTERIM AND PINO, ANSWERS TO THEIR QUESTIONS WERE WRITTEN OUT FOR MARTINEZ. HE WAS CONSTANTLY REMINDED TO READ THE ANSWERS IN A NATURAL SPEAKING VOICE. MARTINEZ WAS SCHEDULED TO RETURN TO THE CUBAN EMBASSY, MONDAY, NOVEMBER 28, WHICH HE HAS FAILED TO DO. HE HAS NOT HAD ANY CONTACT WITH CUBAN OFFICIALS SINCE 2 PM, NOVEMBER 25. MARTINEZ DEPARTED TODAY FOR A NEW YORK HONEYMOON FOR THE REMAINDER OF THIS WEEK. HE FEARS HIS MOTHER IN CUBA WILL LOSE ALL OF HER PROPERTY BECAUSE OF HIS ACTIONS. HE WILL ENDEAVOR TO BRING HER TO THIS COUNTRY AND ONCE SHE IS HERE, DR. BERRIOS STATED MARTINEZ WILL COOPERATE WITH THE BUREAU IN FURNISHING INFORMATION WHICH MAY BE OF VALUE TO U.S. MARTINEZ CURRENTLY MINIMIZES HIS KNOWLEDGE OF SUCH INFORMATION BY EXPLAINING THAT HE WAS THE LOWEST RANKING MEMBER OF AN ELEVEN MAN CUBAN EMBASSY. MARTINEZ WAS IN CONTACT WITH INS AND THE STATE DEPARTMENT NOVEMBER 29, AND HE MAINTAINS HE RECEIVED APPROVAL TO REMAIN IN U.S. MARTINEZ BELIEVES THE BUREAU MADE THIS POSSIBLE. DIANA MARTINEZ, IN ADDITION TO HER STATEMENT, ADVISED THAT HER GIRL FRIEND, AMANDA MOLINA, WHO WORKS WITH PAN AMERICAN HEALTH ORGANIZATION, WASHINGTON, D.C., CALLED HER ON LATE AFTERNOON OF NOVEMBER 26, STATING SHE, MOLINA, RECEIVED WORD FROM A FRIEND OF HERS, WHO WORKS IN THE CUBAN EMBASSY, TO THE EFFECT CUBAN OFFICIALS WERE EN ROUTE TO BALTIMORE IN ENDEAVOR TO STOP HER WEDDING TO MARTINEZ AND DECLARE HIM INSANE. MOLINA SHOULD NOT BE CONTACTED BY WASHINGTON FIELD WITHOUT FURTHER INSTRUCTIONS FROM BALTIMORE; HOWEVER, THE POSSIBILITY EXISTS THAT THROUGH HER, WASHINGTON FIELD MAY BE ABLE TO DEVELOP HER UNIDENTIFIED EMBASSY FRIEND.
