The informant referred to in the enclosed letterhead memo is [WF 1133-S*] (S)

On 12/5/60, Captn. MICHAEL MAHANEY, Office of Special Investigations, MPD, WDC, contacted WFO and advised that FELIX E. HURTADO, who is associated with the Office of the Cuban Delegation to the OAS, was assaulted this date and desired to furnish the details of the assault to the FBI.

Felix HURTADO was interviewed by SAs JOHN G. GOEDTEL and HOMER W. SCHWEPPE at Captn. MAHANEY's Office and voluntarily furnished the details of an assault against him by subject. FELIX HURTADO is of the opinion that the Cubans were taking reprisal against him for past anti-CASTRO actions of his brother, FERNANDO HURTADO, who recently arrived in the U.S. from Cuba and took up residence with FELIX HURTADO at 1104 Vermont Ave., N.W.
