were to be held in abeyance pending receipt by WFO of pertinent details from Baltimore of a recording made by Dr. OSWALD BERRIOS for WFO's use in the interview.

On 12/7/60 the Bureau advised that a translation of the recording was not pertinent. In view of this and in accordance with Bureau instructions SAs JOHN G. GOEDEL and JOHN L. SPURGERS, JR. called on DIMAS CID but she refused to be interviewed by the FBI.

(S) [WF 1133-S\*] later on 12/7/60 learned that ARMANDO FLOREZ, Charge d' Affaires at the Cuban Embassy, proposed to protest to the State Department, the violation of the diplomatic immunity of DIMAS CID by members of the FBI when they attempted to question her.

The Bureau was telephonically advised of the situation, at which time Inspector DONALD E. MOORE instructed WFO to discontinue all attempts to interview the other Cuban officials involved in MARTINEZ' abduction on 11/25/60.

In view of this, WFO has consolidated its cases captioned "FELIPE MARTINEZ RIVERO, IS-CUBA" and "QUINTIN PINO MACHADO, et al, FELIPE MARTINEZ RIVERO-VICTIM, IS-CUBA, KIDNAPING." The latter case has been closed administratively at WFO.

*Cuban Files*  
 The Bureau has been previously advised by airtel dated December 22, 1960, captioned "FRENTE REVOLUCIONARIO DEMOCRATICO (FRD), IS-CUBA," of information furnished by ~~WF 1161-S\*~~ concerning a situation involving the subject and ANGEL De La CRUZ HERNANDEZ. The Bureau will recall that CRUZ, a former Cuban G-2 agent, defected and joined the FRD in Miami. The FRD gave him an assignment to travel to Washington, D.C. and contact the subject, which CRUZ did at the subject's home. The subject apparently became suspicious of CRUZ' credentials and summoned ARMANDO FLOREZ who was followed shortly thereafter by JOSE MOLEON.

After the arrival of FLOREZ and MOLEON, the subject again requested to see the identification paper belonging to CRUZ. This was then shown to FLOREZ and MOLEON, at which point the subject stated there was "something out of order." At this point FLOREZ, MOLEON, the subject and the subject's wife, MIRIAM drew guns and pointed them at CRUZ. CRUZ related to the informant that the subject held a gun at his chest and

stated he could kill CRUZ using as his story that CRUZ threatened to assassinate the subject. The subject also stated that he could get away with this because of his immunity as a diplomat. However, CRUZ related that the subject stated he would let him go at this time and if CRUZ was on the level, he could come back to the subject's home the following day and recover his identification paper which the subject, at this point, took back from CRUZ. CRUZ stated that he immediately departed the home of the subject and arranged to depart Washington, D.C. the following day.
