Enclosed are nine copies for the Bureau with one copy each for the below listed offices of a letterhead memorandum, dated and captioned as above, containing information from [WF 1133-S*]. (S)

It was noted by Special Agents receiving data from the above informant that TAPANES did not state that he planned to organize or to participate in the organization of an espionage ring in the United States for Cuba, however, the manner in which he spoke clearly indicated that this was the purpose of the meeting mentioned in the enclosure. It was further emphasized that the official contact in the United States for this operation would be the Cuban Alternate Representative to the Organization of American States, Ambassador QUINTIN PINO MACHADO.
