He received a telephone message at the FRD Office from an individual who identified himself as QUINTIN PINO MACHADO. He never acknowledged the telephone message nor did PINO call him back. This message was received by MANUEL BRANA who is also associated with the FRD. RIVERO explained that BRANA recognized the name, QUINTIN PINO MACHADO, as being identical with the name of an official of the present Cuban Government. Following this incident, RIVERO advised that BRANA took it upon himself to write the subject a letter stating the subject had no reason to call the FRD office and further he should refrain from making further calls.

Thempselow the Frente Ravolvejondrio

RIVERO heard that the subject called the FRD office one or two times thereafter. He does not know if this individual threatened BRANA. BRANA has never discussed the matter. RIVERO stated that he has never been threatened by the subject.

BRANA was also interviewed in connection with the above matter. BRANA advised that he understood that the office of the FRD received one or two telephone calls from the subject. BRANA had no idea to whom the subject spoke other than that he, BRANA, did not speak to the subject. BRANA related, however, that he wrote a letter to the subject explaining that none of the FRD members would have anything to do with the subject since the subject represented the communist government of Cuba.

BRANA stated the letter was never actually mailed to the subject. In the discretion of members of the FRD, it was decided not to send the letter. BRANA made it explicit that no threats were ever made by the subject against him nor does he have any knowledge that the subject threatened any member of the FRD.

The high ranking Cuban Government official who furnished a description of "Obra Revolucionaria" is Dr. AURELIO GIROUD, former Second Secretary, Embassy of Cuba, Washington, D. C.
