WFO will keep New York advised of the subject's plans for departure from the U.S. and upon receiving definite information as to his departure will request New York to verify same.

The enclosed letterhead memorandum is classified "Confidential," inasmuch as it reveals our investigative interest in an official of a foreign diplomatic establishment and because the information reported could reasonably result in the identification of a confidential informant of continuing value and compromise the future effectiveness thereof.
