It is noted that WFO airtel letterhead memorandum reflects subject's planned arrival at Newark on the afternoon of 6/15/61, via National Airlines.

(S) For the information of Newark and New York, [WF 1262-S*] later learned that the plans of the subject and ROQUE had been changed and that they would instead depart Washington, D. C., via National Airlines at 10:00 p.m., destination Newark, 4/15/61.

On 6/15/61, [WF 1196-S*] advised that he had (S) learned that the subject intended to depart the United States for Cuba via a boat named the "Covadonga" which was scheduled to arrive in Havana, Cuba, on 6/19 or 20/61.

New York is requested to verify subject's departure from the United States aboard the above-named boat.
