ReCGairtel advised that Chicago will submit a report on the subject's activities while in Chicago.

A survey was conducted for the months of July, August, and September, 1961, of the amount of time spent in the Soviet Delegation, 680 Park Ave., NYC, by Soviet UN Secretariat personnel. This survey revealed that the average time spent at the Soviet Delegation by known or suspected intelligence agents employed at the UN was 3,179 minutes. The time spent there during this period by the subject was 2,129 minutes. This is slightly below the average time spent there by the other known or suspected agents, but is accounted for by the fact that the subject was not in the US for the last three weeks of September.
