Specific valuable information obtained since previous report with indication of specific value of each item and what use was made of each item of information involved: LAWSON is the writer of the Communist movement in the motion picture industry and accordingly this informant is an invaluable aide in reporting the Communist infiltration into the motion picture industry and frequently furnishes information regarding more prominent Communist front organizations in Hollywood. This informant continues to advise the office of more important Communist meetings and is usually a great aide whenever a prominent Communist from another jurisdiction visits Los Angeles.
