Reference is made to the report of SA BERNARR M. PIACEK dated May 17, 1950 at Los Angeles.

This report notes that LAWSON'S permanent address is 9354 Burnett Avenue, San Fernando and that he temporarily resides in New York City. During the course of a security investigation of Mr. and Mrs. IRVING MYERS (JEANNETTE) it was determined that the MYERS now reside at 9354 Burnett.

CNDI LA CD 60 has advised that JEANNETTE MYERS was employed by the Hollywood Arts, Science and Professions during 1949. CNDI LA 6769 C advised on October 21, 1949 that JEANNETTE MYERS was a close personal friend of LAWSON. She has been identified by CNDI NY 132 as a Communist Party member and IRVING MYERS has been identified by CNDI LA 3200 as a Communist Party member. (S)(u)

The foregoing information is supplied for the information of the Bureau in view of LAWSON'S current position of national interest.

Investigative reports concerning both JEANNETTE and IRVING MYERS will be submitted in the near future.
