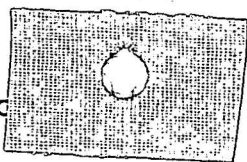
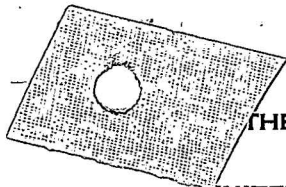

Information contained in relet and enclosures thereto was furnished on 4/24/61 to the Prefecture of Police, Paris; to the Renseignements Généraux, general investigative section, of the Sûreté Nationale; and to the Service des Documentations Extérieures et de Contre-Espionnage (SDECE), French foreign intelligence and counterespionage service, with a request for any information which they might be able to develop or which might come to their attention concerning the subjects during their visit in France (S)

(S) Inasmuch as the above agencies are now aware of our interest in the subjects and have made appropriate notations in their records, this case is being considered RUC since the subjects are not expected to be in France for some time yet. Any information which may be received by this office in the future will be immediately forwarded to the Bureau.
