SA GILBERT G. BENJAMIN determined that LAWSON was present at the home of FRED RINALDO on the night of June 28, 1963; and SA JOSEPH P. MC MAHON determined that a Chevrolet automobile observed at the RINALDO residence on that occasion was being rented by ALBERT MALTZ. SA's BENJAMIN and MC MAHON conducted the surveillance which resulted in observing Mr. and Mrs. LAWSON depart from Los Angeles via Southern Pacific train for Chicago in September, 1963.

Identities of confidential informants and sources contacted by Detroit were not included in Detroit letter to the Bureau dated 10/15/63; and are not known to the reporting office.

Appendix page characterizing the Friday Night Forum, Newark, was furnished Los Angeles by New York letter of 12/2/63.

Details as to the person to be issued subpoena duces tecum for production of records from the Bank of America, San Francisco, is known to the San Francisco Division and original FD 302 covering information set out in details of instant report under title "Funds from the Soviet Union" is maintained by the San Francisco Division. Data included in this report is merely a summary of information relating only to LAWSON.

One information copy of this report is being furnished each of the following field divisions, as it contains information relating to activities of LAWSON within the territory covered by their respective offices: Chicago, Detroit, Newark, New York, San Francisco.
