NY letter to Bureau, dated 11/15/60, entitled, "PLAY FOR CUBA COMMITTEE, RA - CUBA," reflecting that the subject refused to talk to FBI Agents except in the presence of an attorney.

matter except in the presence of his attorney, who he advised is LEONARD BOUDIN. BOUDIN is a law partner of VICTOR RABINOWITZ, who has been active in the FPCC. Information has been received that RABINOWITZ was recently voted off the Executive Committee of the FPCC and allegations that he was a Communist were made against him. On 12/2/60, the Bureau advised that in interview of GIBSON's refusal to discuss anything except in the presence of his attorney and in view of BOUDIN's background, it is not felt that any purpose would be served in pursuing the interview of GIBSON under the terms laid down by him.

In view of the subject's position with the FPCC, an active pro-CASTRO organization, the subject is being recommended for inclusion on the Security Index.
