This is to advise that GUSTAVE SACHNINE of the Renseignements Generaux, general investigative section, Surete Nationale, was contacted on 6/5/61 with respect to information he had furnished relative to captioned subject on 4/18/61. SACHNINE was specifically questioned as to whether the data provided on the foregoing date was of a public source nature. SACHNINE stated that this is definitely not so and that it should be considered confidential in its entirety at this time. He explained that under French law, inasmuch as GIBSON's forging of the letters involved in this matter was never finally adjudicated, he is required to handle this matter on an entirely confidential basis. SACHNINE also advised that the records of the Renseignements Generaux, Surete Nationale, reflect that OLIVER W. HARRINGTON, who is mentioned in the information proved by him on April 18 last, is currently residing at 1 Avenue du General LeClerc, Ivry-sur-Seine, France. (S)
