ReBulet to New York dated 12-6-62 captioned
"Fair Play for Cuba Committee; Registration Act -
Cuba", and Bulet to New York in captioned matter
dated 1-3-63.

This is to advise that under date of 12-12-62
Major VICTOR PORTILLO, head of the Internal Security
Branch of the Spanish High General Staff, was requested
to initiate an investigation through his sources in
Tangier regarding subject and his associates, particu-
larly with reference to GIBSON, to attempt to determine
whether or not GIBSON had left Tangier and his current
whereabouts. (S)

Under date of 1-9-63 Major PORTILLO advised
that no information had come to the attention of
Spanish authorities regarding GIBSON or his associates,
but that investigation had been requested of High
General Staff sources in Tangier. (S)

At such time as any information is received
from PORTILLO, it will be made available to the Bureau
and the New York Office. (S)
