Continued contact has been maintained regarding captioned matter with Major VICTOR PORTILLO PEREZ, head of the Internal Security Branch of the Spanish High General Staff, the last time being 5-17-63. Major PORTILLO advised that no information was developed regarding subject's activities through available Moroccan sources. It is noted that according to Legat, Paris letter to Bureau dated 2-28-63, subject's residence was established as being in Algiers.

In view of the above, no further action is being taken by Legat, Madrid.
