ReNYairtel 9/21/67 requesting Bureau contact Central Intelligence Agency (CIA) to determine feasibility of having CIA source known as "Sugar" contact the subject soliciting information relating to subject's contacts abroad and regarding domestic pro-Chinese communist activities. (S)

"Sugar" is scheduled to contact our intelligence Ad Hoc Committee for a Marxist-Leninist Party, USA during his current trip to the United States. He is aware of the identity of one Ad Hoc Committee member who is also an informant of this Bureau. If he were to contact Frank, it is very likely he would divulge the true name of the Ad Hoc Committee (AHC) informant and thereby jeopardize the informant's dual position as a member of the Communist Party, USA (CPUSA) and an anti-Party faction working within the CPUSA. For this reason it is not believed advisable to have "Sugar" contact Frank (S)

While in the United States "Sugar" has plans to contact a number of individuals affiliated with militant black nationalist and pro-Chinese Communist oriented organizations. The Bureau has no information indicating "Sugar" has plans to contact Frank or that he has established sufficient rapport with Frank to make such a contact. CIA has advised it will furnish to this Bureau the results of any contacts Sugar makes in the United States. (S)

In the event you have any specific questions you desire to be put to "Sugar," you should submit these to the Bureau where they will be handled through Seat of Government liaison with CIA. Do not contact CIA locally relating to "Sugar." (S)

NOTE:

Frank, who has been described by CPUSA General Secretary Gus Hall as the "Chinese paymaster" in the United States, is associated with the pro-Chicom Progressive Labor Party. Frank visited Europe in 1966 where she briefly met Richard Gibson who is identical with "Sugar" (S) Gibson is an American now living in England who was formerly the leader of the Fair Play for Cuba Committee. (The AHC is an intelligence operation projected as a legitimate pro-Chicom organization.) (S) We are declining New York's suggestion to have Sugar contact Frank because it is not felt he is closely associated with her to a degree where such a contact would be logical and also because contact with her could jeopardize the AHC operation. (S)
