Transmitted herewith are nine copies of a letterhead memorandum, captioned and dated as above.

NY T-1 is PSI [redacted] married to a sister of the wife of RAUL ROA, and as the Bureau is aware, is visiting in the apartment of ROA on a daily basis. (S)

NY T-2 is [NY 3374-S\*] (S)

PSI answered the door in ROA's apartment when RICHARD GIBSON arrived; however, JUAN OTERO, described by PSI as one of the Cuban G-2 agents in the room next to ROA's apartment, brushed right by PSI and took GIBSON to ROA. ROA excused himself from PSI's immediate presence and went over and sat down on the sofa with GIBSON where a very lengthy conversation took place in English. PSI was with ADA ROA (in) (S)

[the kitchen] and inquired if the visitor was not one of the Asiatic Friends. She replied that he is not, that he is one of "our American friends in the Fair Play for Cuba Committee, he is the Secretary NOW". Due to the emphasis put on "now" [PSI] assumed his post is temporary. [Informant was] able to hear something concerning "multilith" and "papers", but the thread of the conversation could not be put together. ADA mentioned something about the "Friends" having a hard time, and [PSI] assumed conversation might have had to do with financial arrangements, as ROA definitely did not want [PSI] in the room while he talked to GIBSON. (S)

This memorandum is classified "Confidential", since any revelation of the contents to unauthorized sources could seriously compromise [PSI] and endanger relatives he has residing in Cuba. (S)

One copy is furnished MM for information, since that office has constant interest in Cuban matters, and in order to keep that office informed re productivity of [PSI] [ ] (S)
