On 3/27/62, NY 3229-S, who has furnished reliable information in the past, advised that RICHARD GIBSON, Acting Executive Secretary, Fair Play for Cuba Committee (FPCC) had previously requested this source to travel to San Francisco in an attempt to collect finances which the San Francisco Chapter, FPCC owes to the National Office, FPCC. (X)(u)

This informant advised that GIBSON has furnished this source with \$30.00 for incidental travel expenses, inasmuch as he is travelling gratis on American Airlines, as an employee, although he is required to pay for his meals. (X)(u)

NY 3229-S advised that he plans to depart Idlewild Airport, NYC on 3/31/61, via Flight #17, American Airlines, arriving in San Francisco at 2:30 p.m. He plans to return from San Francisco on 4/1 or 2/62, via Flight #16, American Airlines, departing San Francisco at 1:30 p.m. and arriving at NYC at 9:20 p.m. (X)(u)
