It is noted that there is a printing shop on the third floor of the building located at 220 East 14th Street, NY, NY, over a beauty parlor. Visual observation of this shop shows that it is known as Mandrill Press. Also included on the mailbox at this address are the names MARTIN LEVITT and Young Concert Artists. (S)(u)

The NY Telephone Company Directory for Manhattan contains the listing MARTIN LEVITT, 220 East 14th Street, telephone number GR 5-1691. (S)(u)

A review of the indices of the NYO concerning MARTIN LEVITT located references indicating that LEVITT's print shop has been utilized by various "leftist" organizations in the NY area and that his name has been included on the mailing list for Fair Play for Cuba Committee (FPCC) and Advance. (S)(u)

On 8/7/62, NY 3467-S advised that the FPCC utilized a print shop at 220 East 14th Street, NY, NY, and had recently had the "Declaration of Havana" printed there. (S)(u)

It is noted that on 8/22/62, EDWARD L. BRAUNE, Agent, NY Telephone Company, 140 West Street, NY, advised SA JAMES M. ANDERSON that his records reflect that MARTIN LEVITT has telephone number GR 5-1691 at 220 East 14th Street, NY. The type of service was listed as for a residence and his occupation was that of a self-employed artist. LEVITT's bank reference was listed as the Manufacturers Trust Company, 14th Street and Second Avenue, NY. (S)(u)

The above information may only be made available upon the issuance of the usual subpoena duces tecum.

Logical confidential informants who have knowledge of Cuban activities in the US were contacted during June and July, 1962, and could furnish no further information concerning LEVITT. (S)(u)

Concerning the possibility of ANDRE MARTINSONS being a mail drop for subject, it is felt that subject more probably is using [this address to correspond with CIA source for personal reasons.] It is noted that subject has a reputation as a "ladies man" and according to information furnished by technical coverage of FPCC offices, subject was repeatedly in contact with various women. He also was in contact [with the CIA source] for personal reasons. (S) NY

In view of the above information concerning LEVITT, no further investigation is being conducted towards contacting LEVITT as a source concerning FPCC publications.
