Re Bureau letter to CIA dated 8/2/73 captioned as above, copy of which was furnished Los Angeles with request that it be determine whether captioned subject, currently Professor of Physics at the California Institute of Technology, who was born in Toronto, Canada, on 12/12/21 and is a naturalized U.S. citizen, is identical with one CHARLES A. BARNES known to have been connected with the Fair Play For Cuba Committee

Review of Los Angeles files discloses no information immediately identifiable with captioned subject. However, they do disclose the following information regarding the mentioned CHARLES A. BARNES:

NY 3245-S* on 5/21,22/61 and again on 9/24,25/61 made available the names of persons appearing on addressograph plates at the headquarters of the Fair Play for Cuba Committee (FPCC), Room 329, 799 Broadway, New York City, at that time, including: CHARLES A. BARNES, 3032 "E" Street, San Bernardino, California. (Location: NY 97-1792; LA 105-8734-565,760)

CG 5474-S advised on 9/7/61 that according to RICHARD GIBSON, then acting national secretary of the FPCC, the above mentioned addressograph plates such as the one on BARNES, having no code designation thereon, related to those "members and subscribers" whose membership and subscriptions were then up for renewal. (Location: NY 97-2177; LA 105-8734-760)

NY 3245-S* further advised on 5/20/62 that among records maintained at the headquarters of the FPCC, Room 329, 799 Broadway, New York City, was a list of persons subscribing to "Cuban Press Survey" (self-described as a FPCC publication) which included: Dr. CHARLES BARNES, 3032 "E" Street, San

LA 4033-S on 2/20/63 made available a list of names said to be the general mailing list of the Los Angeles Local - Socialist Workers Party, on which appeared: CHARLES A. BARNES, 3032 "E" Street, San Bernardino, Calif. (Location: LA 100-17375-10344 P.60) ~~(U)~~

Records of the Los Angeles County Registrar of Voters, reviewed on 8/24/73, disclosed a current registration dated 2/6/64 in the name of CHARLES A. BARNES, 1546 Rose Villa Street, Pasadena, which indicates he was previously registered as a voter with the address, 1132 Constance Street, Pasadena. This BARNES is identified in the registration as born in Canada, naturalized at Los Angeles, 5' 11" tall, occupation "professor". He declined to state any political party preference. Although it has not yet been established, it would appear this BARNES is identical with the captioned subject. U

Cuban source ANTONIO PEREZ, 201 East Valley Boulevard, Alhambra, California, and Cuban source MANUEL GONZALEZ, 3000 South Figueroa Street, Los Angeles, who were heads of the July 26th Movement in Los Angeles in 1957 and 1959-1961 respectively and were acquainted with some non-Cubans interested in the Cuban movement including members and sympathizers with the FPCC, advised on 8/30/73 and 9/4/73 respectively they do not recall anyone with the name or background of the subject BARNES.

Mrs. LUCY JOHNSON, Records Administration, INS, Los Angeles, has advised that her indices indicate file number A10 787 421 relates apparently to the subject BARNES but that the file itself is not readily available. U

Investigation is continuing to resolve the problem of identity presented above. When resolved, the results will be submitted in disseminable form as requested. U
